Marketplace Guidelines:

*Retired D56 Items and other accessories are allowed for sale.

*Marketplace table (2'x 6') cost – \$75 each. Electric cost - \$15/outlet. A 50% deposit holds your reserved table – full payment due by 1/1/06. This does not include Hotel accommodations, meals or parking. Table assignments are made upon full payment, signed contract/reservation form and donation. Charges for tables are non-refundable after 1/1/06. Door prize donations: One(1) lighted D56 house for 1-3 occupied tables: Two(2) lighted D56 houses for 4 or more occupied tables. Non-D56 vendors will provide same – of equal quality & value. Each vendor and their donation will be acknowledged during the Gathering.

*No discount signage of any kind is allowed: i.e. signs reading “50% off all items”.

*No additional shelving behind tables will be allowed for selling area, paid table space only.

* Wyndham O'Hare (Marketplace) will be open Friday, April 28, 11am –5pm and on Saturday, April 29, 9 am – 4 pm. Wyndham O'Hare Ballroom (Marketplace) area must be vacated before 5:30 pm Saturday April 29.

*Each Vendor will be given 2 tickets to the event.(Excluding meals)

*We are offering Vendors the opportunity to provide flyers and or coupons, which will be included in the Chicago 2006 Gathering goodie bags given to each attendee.

*Room hopping, Saturday, April 29, only after 9 pm. Direct selling, at any other time, from individual rooms or adjoining parking lot areas will not be permitted. Violators of this selling practice will be asked to leave the Gathering.

*Exhibitor is responsible for their own room reservation and their meals.

*Exhibitor is responsible for collecting sales taxes.

*The Chicago 2006 Gathering Committee does not maintain insurance covering the Exhibitor's property. It is the sole responsibility of the Exhibitor to obtain insurance or absorb any loss or damage.

*Exhibitor assumes financial and legal responsibility, agrees to indemnify and defend the Chicago 2006 Gathering Committee and Host Clubs any claims or expenses arising from the use of the convention premises.
